D. INTERNATIONAL EVENT

1.ALSA Forum

The annual forum is the flagship activity of Asian Law Students' Association, which brings together all ALSA members from various countries for a series of academic and non-academic activities. More importantly, this event marks the beginning of ALSA's office term, where the annual General Assembly, Offline Governing Council Meetings and International Board elections will be held.

2. ALSA Conference

The annual conference is another international event where our members gather and participate in developing ALSA towards an impactful student-run organization. Therein, this event provides members with the occasion to garner more networks, as well as the opportunity to develop their academic knowledge, learn more about the legal system of the host country and engage in academic and cultural sharing.

3. ALSA International Moot Court Competition (AIMCC)

The ALSA International Moot Court Competition is a simulated arbitration hearing of an International Investment Dispute Settlement. Students from all over the world will send in their Written Memorials for the complainant and respondent of a fictional case written by professionals. After the Written Round (Memorials), selected teams will present their memorials for the complainant and the respondent in front of a Panel of Arbitrators in the Oral Round.

Through the competition, participants will be given the opportunity to develop analytical skills and skills in legal research, writing, and advocacy and expand their knowledge on and become exposed to issues of international law in the simulated environment of an international court or an arbitral tribunal. The competition promotes networking amongst law students, encourages the exchange of ideas and perspectives on contemporary legal issues, and, in turn, proliferates the development of the law. The experiences acquired from the AIMCC carry through in later life, helping to shape successful careers in different areas of legal practice.

4. ALSA International Mediation Competition (AIMC)

The ALSA International Mediation Competition is a means to promote, incite and disseminate the use of mediation among younger generations of professionals with a mind-set of effectively resolving disputes. ALSA believes that AIMC will allow students with different backgrounds and academic training to have the opportunity to enhance their mediation skills in an international setting.

AIMC is an educational event that seeks to encourage the effective use of mediation and the open exchange of ideas, experience, and know-how between students from different countries, cultures, generations, and backgrounds. Appreciation and respect for cultural diversity should be shown by all participants.

The focus of AIMC is to effectively combine the use of the Mediator and collaborative problem-solving skills to successfully present the Parties' interests and progress towards resolution. ALSA wishes to empower tomorrow's business people and legal practitioners to better meet the dispute resolution needs of an increasingly cross-cultural and global market.

5. John H. Jackson Moot Court Competition (JHMCC)

It is an international competition on the law of the world trade organization (WTO) organized by the European Law Students' Association ("ELSA") with the technical support of the WTO itself. The competition takes on the form of a simulated hearing of the WTO dispute settlement system.

D. NATIONAL EVENT

1. Rapat Pimpinan Nasional (Rapimnas)

Rapat Pimpinan Nasional atau Rapimnas merupakan forum musyawarah antara National Board ALSA Indonesia dengan para pimpinan Local Chapter untuk menyatukan tujuan serta pandangan dari setiap Local Chapter dan membahas rencana kerja terkait kegiatan-kegiatan yang akan dilaksanakan oleh National Board ALSA Indonesia selama satu tahun kepengurusan. Rapimnas berlangsung selama 3 (tiga) hari dan tuan rumahnya adalah Local Chapter asal Presiden ALSA Indonesia yang baru.

2. Seminar & Workshop Nasional (Semworknas)

Seminar dan Workshop Nasional atau lebih dikenal dengan sebutan Semworknas, merupakan salah satu acara tahunan ALSA Indonesia. Kegiatan ini mengusung kegiatan sebuah seminar dan workshop yang menarik untuk didiskusikan oleh mahasiswa hukum dari setiap Local Chapter. Terdapat 3 (tiga) rangkaian utama dalam acara ini, yakni seminar, round table discussion, brainstorming, dan workshop. Materi seminar tentunya di bidang hukum, disampaikan oleh orang-orang yang mumpuni di bidang dan/atau keilmuannya dengan tema yang bervariatif setiap tahunnya. Saat workshop, peserta nantinya dapat berlatih bagaimana berpraktik sebagai praktisi hukum, seperti halnya melakukan due diligence, membuat kontrak, melakukan simulasi negosiasi, dan sebagainya. Rangkaian acara terakhir adalah City & Culinary Trip berfungsi sebagai wadah untuk meningkatkan keakraban para peserta sekaligus juga mengenalkan budaya dan wisata daerah tuan rumah penyelenggara Seminar dan Workshop Nasional.

3. Pra-Musyawarah Nasional & ALSA Leadership Training (PALT)

Pra-Musyawarah Nasional & ALSA Leadership Training merupakan acara nasional tahunan ALSA Indonesia yang sekaligus merupakan alat kelengkapan ALSA Indonesia yang dimana memiliki rangkaian kegiatan utama berupa pra-musyawarah nasional dan leadership training. Yang diikuti oleh seluruh Local Chapter yang diselenggarakan dalam kurung waktu 3 (tiga) hari.

4. ALSA National Moot Court Competition (NMCC) Piala Mahkamah Agung RI

Kompetisi Peradilan Semu Pidana Tingkat Nasional ALSA National Chapter Indonesia adalah kompetisi peradilan semu antar fakultas hukum perguruan tinggi se-Indonesia dalam lingkup kasus pidana yang diselenggarakan oleh National Chapter bersama Local Chapter tuan rumah. Sebagai Lomba Peradilan Semu tertua dan paling bergengsi, membuat kompetisi ini sangat diminati oleh berbagai universitas di Indonesia, dengan jumlah peserta 16 tim juga dari seluruh universitas di Indonesia.

5. Seminar dan Musyawarah Nasional (Semunas)

Seminar dan Musyawarah Nasional (Semunas) adalah Acara Nasional dan forum tertinggi ALSA Indonesia. Acara Nasional ini diadakan setahun sekali di akhir kepengurusan National Board ALSA Indonesia guna menandakan pergantian kepengurusan. Terdapat 2 (dua) agenda penting didalam Semunas yaitu Seminar Nasional dan Musyawarah Nasional. Seminar Nasional diselenggarakan guna membahas suatu isu hukum yang sedang hangat diperbincangkan di tengah masyarakat serta mencari suatu solusi terhadap permasalahan dengan cara interaksi dua arah antara pembicara dengan peserta seminar. Sedangkan Musyawarah Nasional (Munas) merupakan forum musyawarah tertinggi di dalam National Chapter dimana agenda pembahasan di dalamnya telah dibicarakan terlebih dahulu di dalam Pra-Musyawarah Nasional.




B. MISSION

1. ALSA Symposium 7.0
